- Continue discussion/review strategies to fully engage the community including to conduct “in-person” interactions with the community. Also review status of "live" community use of force survey.
- Discuss Investigation of Deadly Force Deployment and Affiliated Critical Police Incidents (SOP #12-045) draft provided by FCC Police Department.
- Continue to finalize Committee recommendations relative to Police Department General Orders entitled "Use of Force," effective September 24, 1987 (last reviewed March 3, 2016) in conjunction with Sheriff's Office General Orders entitled "Response to Threat" effective July 1, 2020 (last reviewed August 15, 2020 and subsequent revision dated September 18, 2020), Police Department GO 3-1 draft and Camden New Jersey Police Department Use of Force policy, review/finalize recommendations on outstanding issues including: Pending: Staff training and resource funding input to make use of force policy effective.
- Continue to finalize Committee to output reporting for Police Department General Orders entitled Reporting the Use of Force, effective September 24, 1987 (last reviewed March 3, 2016) in conjunction with Sheriff's Office General Orders relative to reporting uses of force.
- Committee to continue discussions/reviewing recommendations relative to Police Department General Order 2-1: Bias Reduction and Sheriff's Office General Orders (# TBA) Bias Awareness/Reduction/Elimination effective September 10, 2020 (received October 14, 2020).
- Committee to continue discussions/reviewing recommendation relative to Committee request or Police Department and Sheriff's Office General Order 2-3 entitled, "Internal Affairs" to be provided to the Committee and any Sheriff's Office General Orders/Policy relative Internal Affairs policies, also to be provided to the Committee.
- Discuss/review recommendations relative to Police Department FCCPS School Resource Officers memorandum, entitled, "Relations with Law Enforcement Authorities" (undated but noted as 7/20; File: KNAJ) and "Memorandum of Understanding Between The Falls Church Police Department and the Falls Church City Police Schools" dated 3/26/2008 (Last review 3/20/2008).
- Discuss possible methods for review of incidents provided to the committee.
- Establish the next meeting agenda.

Accessing Teams – New Users

Smartphone: If you plan to view the meeting on a smartphone, access your preferred app store to download the “Teams” app. You will have to allow Teams access to some features on your phone and accept their terms and conditions.

PC/Windows: If you plan to view the meeting on a personal computer, visit www.microsoft.com to download and install the program. You will have to allow Teams access to some features on your computer and accept their terms and conditions.

After downloading Teams:

Click the advertised meeting link to join the Teams meeting.

When the app opens, click ‘Join now’.

The meeting will start with your microphone and video features turned off. As an observer, you can view or listen to the meeting without these features. If you are a meeting participant, you should enable at least the microphone feature. Video is not required but may be useful. Depending on your role in the meeting, there may be restrictions on whether you can speak during the meeting.
