2018 Decal Contest Artwork Release

I, _____, am over 18 years of age and the parent or legal guardian of _____, (the "Student") who submitted certain artwork or graphic images (the "Art") to the City of Falls Church Treasurer through his high school for use in the City of Falls Church Decal Competition (the "Contest"). The Student and I acknowledge that the Student submitted the Art to the Contest for the use of the City of Falls Church. On behalf of myself and the Student, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I hereby grant to the City of Falls Church the right to use, license, and incorporate the Art, and any portions or images contained therein, in whole or in part in as it sees fit and appropriate in any manner and in all media, in any and all versions, whether now known or hereafter devised, in any and all languages throughout the universe and in perpetuity. The City of Falls Church has the right to change, edit, alter or modify the Art in any manner. If the Art is chosen for further display, use or promotion, the City of Falls Church may publicize the Student as the artist, but I understand that the City of Falls Church cannot accord us credit in all circumstances. All submissions will become the property of the City of Falls Church, and the City of Falls Church, on receipt of this Release shall become the sole and rightful owner of any and all material included in the Art. I understand that submissions, including the Art will not be returned, and that the City of Falls Church reserves the right to destroy all submissions. The City of Falls Church is not responsible for lost, damaged or misdirected submissions at any time.

If the Student is a contest winner and/or if my Student's Art is chosen for further display, I further grant to the City of Falls Church the absolute and irrevocable right and permission to photograph, film, videotape, record and/or portray the Student's name, voice, portrayal, actions and/or likeness in connection with the Contest and other uses the City of Falls Church may make of the Art, and to use the results and proceeds thereof as follows: (a) to copyright the Art in the City of Falls Church's own name or in any other name (the Art shall be considered a "work made for hire"); (b) to use, incorporate, broadcast, distribute, re-use, publish, re-publish, alter and/or edit the Art and/or the Student's name, likeness and portrayal in whole or in part, severally or in conjunction with other material for any purpose and in any manner whatsoever as the City of Falls Church so chooses in any and all media, now known or hereafter devised, in any and all versions, throughout the universe and in perpetuity, as well as for promotion, merchandising, publicity and advertising. The City of Falls Church has no obligation to use the Art or the Student's name, voice or likeness.

I represent that I have the right and authority to grant to the City of Falls Church the rights granted herein, including without limitation the right to use the Art without the necessity of making payments to or obtaining the consent of any third person or entity. I represent that this release does not in any way conflict with any existing commitment on my part, nor will I enter into any agreement in the future that conflicts with or in any way limits the rights I have granted herein.
