FOR JOB ORDER CONTRACTING SERVICES; TO EXPEND UP TO \$1MIL PER FISCAL YEAR UNDER EACH CONTRACT; AND TO RENEW THESE CONTRACTS FOR FIVE (5) ADDITIONAL ONE-YEAR TERMS, SUBJECT TO APPROPRIATION OF FUNDS MOTION to authorize the City Manager, on behalf of the City, to sign agreements with Brown & Root Industrial Services LLC, Centennial Contractors Enterprises, Inc. and The Matthews Group, Inc. for job order contracting services; to expend up to \$1 million per fiscal year under each contract; and to renew these contracts for five additional one-year terms, subject to appropriation of funds by City Council in the budget PASSED 7-0.
